## February 18th Technical Session - 4:30 - 5:30

Speaker: David Ammons

Topic: Trends in Oil and Gas Royalty Disputes

Mr. David Ammons is a commercial trial lawyer at Winstead PC, which is one of the largest business law firms in Texas. Topic: When Energy Companies go Bankrupt

Mr. Eppich will give a brief discussion about why energy companies seek bankruptcy relief, some signs that suggest a company may be in financial distress, and how to navigate the bankruptcy process once a company files for bankruptcy.

Joshua N. Eppich is a partner at Shannon, Gracey, Ratliff & Miller, LLP. He focuses his practice on bankruptcy and creditor's rights, primarily representing debtors and creditors in all aspects of bankruptcy proceedings and out-of-court restructurings and work-outs. Mr. Eppich has assisted debtors, creditors, trustees, and official committees of unsecured creditors in cases throughout the United States. He also provides bankruptcy advice on various types of transactions, including energy transactions and the acquisition of distressed assets. Mr. Eppich attended Brigham Young University where he earned a B.S. in Business Management with an emphasis in Finance. He is licensed to practice law in Texas and is a graduate of the Southern Methodist University Dedman School of Law where he was an Articles Editor for the International Law Review.
